Delegates with proven residence outside of California must provide a total of five (5) or more full page ads in the Souvenir Program.

All content in the souvenir program magazine, changes and placement is subject to approval by Virgelia Productions, Inc. Changes to the advertisements may be made at any time by Virgelia Productions, Inc. with or without notice.

Full payment and artwork must be received upon submission of advertisements. All sponsors ads in the souvenir program is due 30 days before the pageant. Late submissions will be charge with late fees
